

Requirements for the publication of articles in the journal "Technical and Agricultural Sciences".

International scientific-practical magazine of Lankaran State University "Technology and Agrarian Sciences" Ministry of Education of the Republic of Azerbaijan by decision of the Scientific Council of Lankaran State University dated April 27, 2022 (Protocol No. 04), University No. 4/38, May 11, 2022 International standard identification number (ISSN 0000-0000) established according to the order dated 00.00.0000 and by the decision dated 00.00.0000 (protocol No. 00-R) of the Presidium of the Supreme Attestation Commission under the President of the Republic of Azerbaijan " The list of periodical scientific publications recommended to publish the main results of dissertations in the Republic of Azerbaijan" is included in the sections of technical and agricultural sciences.

1. The journal mainly publishes articles corresponding to its profile in the following areas of science:

2. The journal is published 4 once a year.
3. Articles are accepted in Azerbaijani, English Turkish and Russian.
4. The journal publishes articles from the leading countries of the world in the field of science or technology.
5. The journal publishes articles on its profile. The journal has sections on technical and agricultural sciences.
6. The texts of articles should be printed in Times New Roman-12 font (for example, Latin in Azerbaijani, Turkish alphabet in Turkish, Cyrillic in Russian, English alphabet in English) with 1 interval. The article should be placed on A4 format as follows: left- 25 mm, right- 15 mm, top- 20 mm, bottom-20 mm, paragraph-1.25. Authors can use the MS Word TEMPLATE file to prepare articles.
7. Each article in the journal is given on a new page, and at the top of the page there is a header indicating the name of the journal, year, volume, number, beginning and end of the article.
8. The article should be formatted as follows: at the beginning of the page, indicate the UOT indices or PACS type codes, then the title of the article, then the last name, first name, patronymic of the author (authors), the institution (s) in which he works, and the address of this institution(s), e-mail address(es) of the author(s).
9. At the beginning of the article, an abstract of 150-300 characters and keywords of 5-10 words in the language in which it is written should be given. Key words should be given in three languages (the languages in which the article and abstract are written). The volume of articles devoted to the results of research works should be 6-15 pages, and the volume of review articles should be up to 20 pages.
10. The structure of the article should basically provide the following sequence: introduction, scientific, practical and theoretical and methodological substantiation, materials, equipment and devices used, research objects and methods (methods), order and place of the research, methods. processing of results, obtained results and their discussion, results and proposals, list of references. Depending on the content of the article, the author (authors), if necessary, may make certain changes to the structure of the article.
11. The figures given in the article must be consecutively numbered. The signature should not be more than 15 words. The PNG and JPEG formats are considered suitable for images. All images should be placed where they are linked, and not at the end of the text. The tables given in the article should also be numbered consecutively. The title of the table and the explanation of the abbreviations given in it should not exceed 15 words. All tables should be located in the appropriate places of references, and not at the end of the text. All figures and tables should be referenced in the text of the article.
12. At the end of a scientific article, according to the nature of the scientific field and the nature of the article, the scientific conclusion of the author (authors), the scientific novelty of the work, the significance of the application, economic efficiency, etc. are indicated. must be given in a clear and justified manner.
13. There should be links to scientific sources related to the topic of the article. The list of

references at the end of the article should be numbered either in the order in which the cited literature is mentioned in the text (for example, [1] or [1, p. 119]), or in alphabetical order. If the same literature is cited again elsewhere in the text, then the cited literature is indicated by the same number.

14. Information about each reference given in the bibliography must be complete and accurate. A bibliographic description of the cited source should be given depending on its type (monograph, textbook, scientific article, etc.). When referring to scientific articles, materials or abstracts of symposiums, conferences and other prestigious scientific events, it is necessary to indicate the title of the article, report or dissertation. When providing a bibliographic description of the cited source, the requirements of the "Reference literature" section of the "Reference literature" section of the current instruction of the Higher Attestation Commission under the President of the Republic of Azerbaijan "Rules for defending dissertations" must be observed. take as a basis.

15. The bibliography should be written in the Essentials APA style.

16. In the list of references at the end of the article, preference should be given to scientific articles, monographs and other reliable sources for the last 5-10 years.

17. In addition to the language in which it is published, the summary of the article should be given in two more languages. Abstracts of the article in different languages must be identical to each other and correspond to the content of the article. In the article, the scientific conclusion of the author or authors, the scientific novelty of the work, the significance of the application, etc. should be summarized in the summary. Abstracts must be strictly edited from a scientific and grammatical point of view. Each abstract must include the title of the article and the full name of the author or authors.

18. According to the list of literature, the most recent (last 5-10 years) references related to the topic of the article should be included. All sources in the bibliography should be cited in the text.

19. In addition to the language in which it is published, the summary of the article should be given in two additional languages. An abstract of an article in different languages should be identical and reflect the content of the article. In the article, the scientific conclusion of the author (s), the scientific novelty of the work, the significance of the application, etc. should be summarized in the summary. The article and abstract must be strictly edited from a scientific and grammatical point of view. Each thesis must contain the full title of the article, the surname and initials of the author (authors).

20. Keywords should be given in three languages - the languages in which the article and abstract are written.

21. At the end, the dates of receipt of the article by the editorial office, direction for revision and acceptance for publication are indicated.

22. If a fact of plagiarism is found in the article and violation by the author (authors) of the rules of scientific ethics, the article is not published and is not returned.

23. An article submitted to a journal must not be published in another journal or submitted to other journals for publication. The main requirement is its compliance with high scientific criteria (relevance, scientific novelty, etc.).

24. Articles published in the journal are protected by copyright, and all publications of these articles the rights belong exclusively to the journal "Technical and agricultural sciences".

25. Articles should be recommended or submitted for publication by a visiting editor (deputy editor-in-chief on topics) or one of the specialist members of the editorial board after receiving a confidential opinion from anonymous reviewers (experts). At the end of the article, the surname (in full) of the profile editor (deputy chief editor on topics) or a member of the editorial board, his academic title, academic degree and academic name are indicated. In case of refusal to publish the submitted article, the editor of the periodical scientific publication must send the author a reasoned response in writing.

26. In connection with the publication of the article, the editors of the journal confirm the consent of the author or authors that the submitted article has not been previously published (with the exception of the version of the article published in the form of a thesis), so that the

version of the article in any language is not sent simultaneously to other scientific periodicals, and that the scientific article related to the article is to prepare a questionnaire reflecting the institution in which the research work was carried out. The author(s) must sign this questionnaire and send it to the editor or visit the website of a scientific periodical, fill out the electronic version of the questionnaire and confirm it electronically.

27. It is not allowed to publish serial articles in the journal under the heading “in our previous issues” or “in the next issue”.

28. Corrections and comments about serious errors or technical shortcomings found in articles published in previous issues of the journal may be republished by the author (authors) in one of the next issues of the scientific publication. The title of the article listed in the FIX section must be the same as the title of the previous article.

29. Necessary copies of the journal are sent to organizations of the Republic of Azerbaijan, to which abstracts of dissertations are sent, including the Higher Attestation Commission under the President of the Republic of Azerbaijan, in accordance with the specializations of technical and agricultural sciences.

The number of copies of each issue of the journal sent to each of these libraries is at least two copies.

30. The editors of the journal are not allowed to charge fees for the publication of articles in this scientific publication from doctoral students and dissertators.

31. In case of refusal to publish the submitted article, the editors of the journal send the author a written reasoned response.
